!READ THESE COMMENTS!

This is the section of the BOL (Bill of Lading) that you need to look at closely. PKG TYPE "SKD" means skids (pallets). This section tells you the number of pallets you should be receiving (one pallet will have many boxes of flooring stacked on it). PKG TYPE "box" or "carton" tells you the number of SEPARATE boxes you should be receiving - these boxes are typically 6 feet long, and contain moldings. Flooring boxes that are on the pallets do not count as separate/moldings boxes. The consignee listed on this BOL is being delivered 2 pallets of flooring and 3 separate boxes of moldings. Very important: if the number of skids (pallets) and boxes listed on your BOL does not match what you have received, YOU MUST have the driver make a note of the discrepancy on the BOL. Furthermore, you must inspect the packaging on all boxes (including those on the pallets) for damage. If you find any damaged boxes, YOU MUST have the driver make a note of the damage on the BOL. IF YOU DO NOT MAKE A NOTE OF DAMAGES OR SHORTAGE OF PRODUCT ON THE BOL AND HAVE THE DRIVER SIGN IT, YOU WILL NOT BE REFUNDED FOR DAMAGED OR MISSING GOODS. NO EXCEPTIONS.

Note 1 - Where the rate is dependent on value, shippers are required to state specifically in writing the agreed or declared value of the property.
The agreed or declared value of the property is hereby specifically stated by the shipper to be not exceeding.

SPECIAL INSTRUCTIONS:
